Presentation title: Phthalates Reduction Project in Superfund Source Areas

Topic: You have seen them in mac and cheese. Phthalates are everywhere but we are making progress on reducing them! Phthalates are endocrine disrupting plasticizer chemicals that are in a large number of products from personal care products to flooring. They cause reproductive problems in humans and in wildlife and caused recontamination problems after the Commencement Bay Superfund site was cleaned up. This presentation will cover recent health effects in humans and wildlife and policies for addressing phthalates. We will describe our new project in which we are looking at products used outdoors that may contribute to phthalates in stormwater.

Speaker: Heather Trim, Zero-Waste Washington. Heather Trim, Executive Director, Zero Waste Washington, has more than 20 years of experience on environmental issues including policy development, advocacy, coordinating coalitions, outreach, grassroots community engagement and research. She works for improved recycling and product stewardship throughout Washington. She collaborates with key partners to develop cutting edge policy at the State level and local level. She also leads up research projects and the plastics pollution reduction program. Heather provides strategic organizational guidance to Zero Waste Washington. She collaborates with the Board of Directors, offers leadership on strategic planning, and provides financial oversight. Most recently as Science & Policy Director at Futurewise, she focused on ecosystem health and water quality. For over 10 years at People for Puget Sound, she focused on protections for the marine environment and also supported Zero Waste Washington's medicine take-back campaign. Since 2006, she provided leadership at Zero Waste Seattle, which has run campaigns addressing the use of Styrofoam food containers, plastic bags, and unwanted phonebooks, among other waste reduction efforts. She has worked with volunteer scientists on a number of water quality assessment projects in Los Angeles and in the Pacific NW.
