

## Reproductive & Environmental Health Science Training for Health Advocates, Educators & Health Care Professionals

November 12-15, 2012 Bolinas, California

The Collaborative on Health and Environment (CHE) invites you to apply for a training on reproductive and environmental health science. Research shows that reproductive health is negatively impacted by environmental stressors that women, men and children are regularly exposed to. Vulnerable populations bear an unequal burden of these environmental exposures. This training is part of a series of Primary Prevention Environmental Health Trainings conducted by CHE.

This training is designed for people working as healthcare providers, advocates, educators, and community activists who want to bring a greater emphasis on environmental health to their work. The goal is to deepen participants' basic scientific understanding of environmental factors affecting reproductive health so they can be more effective champions for a healthier world. The training will present evidence-based science in lay language. You do not need a formal scientific background in environmental health or other sciences to apply.

The training will be held at Commonweal (www.commonweal.org), a health and environmental research and education institute in Bolinas, California, one hour north of San Francisco. Commonweal's retreat center overlooks the Pacific Ocean – an ideal place for active learning away from the demands of day-to-day responsibilities. The training, as well as room and board, is offered free of charge in a comfortable and supportive environment.

## **Training Topics**

- Healthy fetal and early life development.
- The impact of chemical exposures, nutrition, social stressors and other factors on development early in life and throughout the lifespan.
- The complexity of interconnected factors that influence health.
- Risk assessment as the government process of determining chemical safety.
- How to effectively communicate concerns when there is scientific uncertainty.

The Collaborative on Health and the Environment (CHE) is a diverse partnership of individuals and organizations working collectively to advance scientific knowledge and effective action to address growing concerns about the links between human health and environmental factors.
